# Summary of Changes to the CFS 2.0.0

Fair Trade USA®

Version 1.0.0



#### Introduction

In May 2021, Fair Trade USA completed a major revision of the Capture Fisheries Standard (CFS). The revised CFS 2.0.0 incorporates and replaces Fair Trade USA's former CFS 1.1.0. The new updated version improved upon the previous requirements to bring more benefit to fishers and workers around the world. As part of this revision, we have harmonized core principles and requirements with other Fair Trade USA's producer standards (Agricultural Production Standard and the Factory Standard for Apparel and Home Goods). We have also restructured the CFS to better reflect the realities and groups of fishers we work with. Moreover, we added new topics such as grievances, updated the requirements and expectations in the Resource Management Module, expanded the Internal Management System, and expanded upon the Premium Expenditure Rules.

This document includes a comparison and summary of changes to each compliance criterion between the CFS 1.1.0 and CFS 2.0.0. For any questions on this document or the changes to the Standard, please email us at <a href="mailto:standards@fairtradeusa.org">standards@fairtradeusa.org</a>.

### Reading this Document

This document lays out the changes in the CFS 2.0.0 in comparison to the previous version CFS 1.1.0. The document is divided by the CFS Modules, and within the Modules there is a table divided into four columns which include the new nomenclature in CFS 2.0.0, previous nomenclature in CFS 1.1.0, a summary of the changes, and a final column defining whether the criterion is *new* or *not new*. All the deleted criteria are listed at the end of the document as a separate section.

Criteria considered as *new* are those which did not exist in the previous version of the CFS, **and** those criteria which underwent a significant change during the revision. Fair Trade USA defined which criteria are considered *significantly modified* based on the level of change required by Certificate Holders in order to comply with the revised language. All the criteria categorized as *new* will have extended time for Certificate Holders to come into compliance. Please revise the *Capture Fisheries Standard 2.0.0 Transition Policy* for more details on the transition process.
